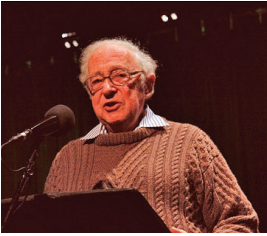

Isaiah Sheffer was the creative force behind Symphony Space from the day he and Allan Miller opened the doors for *Wall to Wall Bach* on January 7, 1978. As the Founding Artistic Director, Isaiah created and directed many of Symphony Space's beloved programs including *Selected Shorts*, *The Thalia Follies*, *All Write!*, and *Bloomsday on Broadway*. He captivated, enlightened, and entertained all of

us: audiences, artists, colleagues, and the community alike. Isaiah passed away on November 9, 2012.
